RE Staff Report for June

This month the Religious Education has slowed down some for the summer - There are ongoing messy playdates on the first and third Sundays of the month.

For the first time since the pandemic, the Youth Group had an inter-congregational Youth Con on June 16th-18th. Tallahassee and Buckman Bridge youth joined us, and we have set a loose schedule for ongoing North Florida Cons. Buckman Bridge will host a con in Sept/Oct, and Tallahassee will host one in the Spring of 2024.

The following week, we were able to send two of our Youth to the General Assembly. They were sent with two chaperones, and though there were a couple of hiccups with travel, they made it there and back safely. They are very grateful for the financial and community support from the congregation, and they're working on writing up reports that will be shared soon.

James has been working on getting OWL coordinated for a Fall start. They sent out an interest form to see what kind of response we have from the congregation, and plan to share it with the larger Gainesville community as well. The current schedule includes 3 classes being taught; 4-6, 7-9, and 10-12.

James has added two new members to their CYREC Committee, and they have agreed to expand their reach to include James' new role as Director of Lifespan Faith Development.

UUFG Governing Board Meeting Minutes

26 June 2023

Board members present: Mary Anthony, Diane Depuydt, Bev Giordano, Leah Cobb Lee,

Congregants present: Erin Parish, Debra Neill-Mareci, Sue Boone, Alice Gridley, and Jeanne Gossman

- 1. Gathering and Meeting Preparation
 - a. Welcome, Call to Order, Quorum; called the meeting to order at 6:31 pm. We have a quorum.
 - b. Chalice Lighting and Reading by Leah Cobb Lee.
 - c. Board Covenant: All members read, "Inspired by our Unitarian Universalist principles, together we guide our congregation and its mission and vision with transparency, gratitude, and respect."
 - d. Personal check-in
 - e. Confirm and assign roles: Diane is timekeeper; Martha is writing gratitude cards; no external observer.
 - f. Confirm agenda/any updates
- 2. Congregational Input: Alice Gridley congratulated the new Board members.
- 3. Consent Agenda
 - a. Staff Report (Att. 1)
 - b. Treasurer's Report for May 2023 (Att. 2)
 - c. Minutes of May 22, 2023, meeting (Att. 3)
 - d. Fellowship Council Report for June 13, 2023, meeting (not in package distributed prior to meeting) Mike Hazlett to take Diane Depuydt's place on the Council.

Motion: Martha moved to approve the consent agenda, except for Fellowship Council Report. Norden seconded, and the motion was passed unanimously.

- 4. Discussion/Action Items/Visioning
 - a. Hourly rate for childcare workers Mary Anthony (Att. 4 Finance Committee Report). We have one childcare worker and are looking for an additional one. The Finance Committee recommended raising the pay rate to \$17/hour. At this pay rate, we can employ two workers for 3.25 hours each Sunday. We are a size 2 congregation with this hourly wage recommended by UUA. We may go over budget, as we provide childcare for other congregational meetings. Motion: Leah moved to increase the pay rate to \$17/hour for childcare workers. Mary seconded, and the motion passed unanimously.
 - b. Masking policy Diane Depuydt asked to have the masking policy reconsidered as she received negative feedback from the congregation after the decision to continue requiring masks made at last month's Board meeting. Debra Neill-Mareci believes it's time to make mask wearing a personal choice. Bev Giordano recalled

that Rev Christe had stated at the last Board meeting that the UUA was still requiring masks for indoor gatherings of 30 or more people. Leah stated that the UUA does not require masking, but it says that singing requires more care. Leah commented that we need to let go of the idea that masking is only for COVID. More children are missing vaccines, and people are at higher risk for getting sick from non-COVID causes. Medical costs and cost of living are higher than four years ago, many times leading to medical debt. We need to protect the people we worship with one hour a week. Diane thinks the question needs to be brought to the larger body of the congregation. Sue stated that all attendees at GA were required to be masked. Motion: Leah moved to schedule an online congregational meeting to discuss the masking policy. Norden seconded, and the motion passed unanimously.

c. Juneteenth staff holiday – Leah Cobb Lee – Juneteenth became a federal holiday this year. Is UUFG going to add this as a paid holiday for staff members? Staff members have 10 paid holidays now. Motion: Martha moved to add Juneteeenth as a paid holiday beginning in 2024. Diane seconded, and the motion passed unanimously.

5. Management and Facilities:

- a. Rental rate for Alcoholics Anonymous (AA) group Martha Soles stated that AA asks for a \$2 donation from each meeting attendee. The group usually has fewer than 20 people in attendance and cannot cover the \$35/hour Social Hall rental fee if they don't have enough attendees. They meet at UUFG on Sunday evenings. AA has asked for a discounted rental rate. Bev recalled that the Board had the same discussion about the Veg4Life group and decided against offering a rent discount. The Common Room rents for \$25/hour. Classrooms rent for less. Mary suggests offering AA the Common Room or a classroom; if they need a larger space, we can discuss moving them to the Social Hall. Action Plan: UUFG will offer AA the Common Room for \$25 (minus the 20% nonprofit discount), and if this is not acceptable to AA, they should come back to the Board. Cam will share this decision with the AA group.
- b. Solar panel account update Mary Anthony says they are creating a separate money market account for the solar panel project. We would need a contingency plan for donors if UUFG did not raise the needed money by a certain deadline. Mary contacted an attorney who is willing to do this paperwork for us. We need to schedule an online congregational meeting in early August to determine member support for this project. We need to have it under contract by July 1, 2026, to qualify for federal funds. We have half the price in promised contributions; will need to raise the balance over a period of time. Motion: Leah moved to schedule an online congregational meeting on August 7, 2023, to ask the congregation to vote on the solar panel project and the masking policy. This will be a binding vote on the solar issue. Norden seconded, and the motion passed unanimously.

6. Leadership and Governance

a. Interim Minister search update – Mary Anthony and Norden Lucke-Tim Christy planned to meet with people at GA. The Personnel Committee talked with

someone who is a Zen Buddhist teacher who might be interested and forwarded this information to Tim who will reach out after GA. Mary clarified that the Personnel Committee is recommending a "three bucket approach" —a local person to provide pastoral care, a person for the pulpit on Sundays, and someone (local or remote) for staff supervision and governance. Erin stated that until then, the Worship Committee plans to use an outside minister for one Sunday a month. The Worship Committee will do one service a month. UUFG groups do take turns doing one service a month, and individuals from the congregation will do one service a month.

- b. Interim Minister funding online option Leah Cobb Lee when people use Vanco to donate to UUFG, we could offer a third option (i.e., to donate to the Interim minister fund). Motion: Leah moved to allow Cam to add this button on the donation site. Norden seconded, and the motion passed unanimously.
- c. Foundation Director- Motion: Martha Soles moved to approve Kristin Stevens as the new Foundation director. Diane seconded, and the motion passed unanimously. Jeanne reported that the fossil fuel resolution brought forth at GA failed to pass.

7. Wrap Up

- a. Emerging concerns –Erin received an email from the Personnel Committee that the potential candidate for the AV tech job is no longer interested. Erin will be doing this task and training other congregation members to provide AV services.
- b. Calendaring & Action Items online congregational meeting on August 7, 2023.
- c. Gratitude notes Mary recognized Martha, Diane, and Bev for their work on the Board this past year.
- d. Board Process went well
- e. Personal Check-out -
- 8. Adjournment the meeting adjourned at 7:53 PM. The next regular meeting of the Board will be on July 24, 2023.
